Re: ICRA Credit Rating for Rs 20-crore LT-Market Linked Debentures of Satya MicroCapital Ltd. (instrument details in Annexure)

Further, you are requested to inform us



immediately as and when the borrowing limit for the instrument rated, as above, or as prescribed by the regulatory authority(ies) is exceeded.
