

## FAMILIARISATION PROGRAMMES FOR INDEPENDENT DIRECTORS

As a part of agenda of Board/ Committee meetings, presentations are regularly made to the Independent Directors on various matters inter-alia the organization structure, Company's strategy, business model, operations, markets, product offerings, finance, risk management framework, technology, quality updates and other relevant areas on a quarterly and annual basis along with quarterly/ annual results at the Board meetings and Audit Committee meetings and/ or other meetings called to explain the same.
- ✓ Updates on relevant regulatory changes and new developments are presented to the Directors, from time to time;
